FACULTY/STAFF ADVISOR CONSENT FORM

The following criteria must be met to be a faculty/staff advisor for a Registered Student Organization:

- ⇒ Full-time faculty/staff member
- ⇒ Part-time faculty/staff member who is not enrolled in any degree program
- ⇒ Advisors must actively participate in the organization and regularly attend meetings of the organization

All organizations must have at least one (1) faculty or staff advisor who works closely with the organization and serves as its immediate liaison with the Office of Student Involvement and Leadership. An advisor is defined as any member of the faculty or professional staff whose duty shall be to counsel the organization. The advisor shall be available to meet with members of the organization at their regular meetings or at special call meetings. The University holds the advisor of an organization responsible for the conduct and activities of the organization that is specifically the advisor should do the following:

- ⇒ Assure that the activities are in keeping with the objectives of the organization
- ⇒ Make certain that the activities are in keeping with University regulations
- ⇒ Maintain orderly meeting
- ⇒ Suggest courses of action when the need arises
- ⇒ Encourage the pursuit of desired goals and achievements

Advisors of student organizations are also expected to:

- ⇒ Be present at all major on-campus and off-campus activities sponsored by the organization
- ⇒ Provide an atmosphere for growth among the members
- ⇒ Review requests and assume responsibility for activities
- ⇒ Inform organizations of institutional changes affecting their operations
- ⇒ Be present during all membership intake activities, initiations and inductions
- ⇒ Make certain that students in the organization are familiar with the Arkansas Law on Hazing (See *The Roar*, page 33)

The advisor or his/her designee must attend all major activities of the student organization (e.g., dances, concerts, etc.). The designee must be a faculty or staff member of the University of Arkansas at Pine Bluff. If the advisor plans to have a designee attend a major event, the Office of Student Involvement and Leadership must be notified at least four (4) week days before the event. The use of a designee in no way minimizes the advisor's responsibility for the conduct and activities of the organization. If at any time during the year you find that you cannot remain as advisor to an organization, please notify the Office of Student Involvement and Leadership.
