Field Instructors' Assessment of Student's Achievement of Practice Behaviors n=19

Fifteen field instructors' rated nineteen students' achievement of practice behaviors on a scale of 1 to 5 for final semester fall 2015, with five being the highest rating. A mean score of 4.00 is the program's benchmark for achievement of the practice behaviors. There should have been twenty-one students, but one student withdrew and the other took the course the previous year.

Competency 1: Demonstrate ethical and professional behavior contains five practice behaviors as follows: (1.1) Make ethical decisions by applying the standards, of the NASW Code of Ethics, relevant laws and regulation, model for ethical decision-making, ethical conductor research, and additional codes of ethics as appropriate to context: 52.6% of field instructors responded excellent, 15.8% above average, and 31.6% average. A total of 100% of the field instructors responded 3.0 or higher. The aggregate mean is 4.21 which is higher than the program's benchmark. (1.2) Use reflection and self-regulation to manage personal values and maintain professionalism in practice situations: 47.4% of field instructors responded excellent, 21.1% above average, and 31.6% average. A total of 100% of the field instructors responded 3.0 or higher. The aggregate mean is 4.15 which exceed the program's benchmark. (1.3) Demonstrate professional demeanor in behavior, appearance, and oral, written, and electronic communication: 42.1% of field instructors responded excellent, 15.8% above average, 31.6% average, and 10.5% deficient. A total of 89.5% of the field instructors responded 3.0 or higher. The aggregate mean is 3.89 which is slightly under the program's benchmark. (1.4) Use technology ethically and appropriately to facilitate practice outcome: 42.1% of field instructors responded excellent, 5.3% above average, 42.1% average, and 10.5% missing response. (2.2) Present themselves as learners and engage clients and constituencies as expert of their own experience: 47.4% of field instructors responded excellent and 21.1% above average, and 31.6% average. A total of 100.0% of the field instructors responded 3.0 or higher. The aggregate mean is 4.15 which exceed the program's benchmark. (2.3) Apply self-awareness and self-regulations to manage the influence of personal biases and value in working with diverse clients and constituencies: 47.4% of field instructors responded excellent and 21.1% above average, and 31.6% average. A total of 100.0% of the field instructors responded 3.0 or higher. The aggregate mean is 4.10 which is higher than the program's benchmark.

A total of 73.7% of the field instructors responded 3.0 or higher. The aggregate mean is 2.89 which does not exceed the program's benchmark. (4.2) Apply critical thinking to engage in analysis of quantitative and qualitative research methods and research findings: 31.6% of field instructors responded excellent, 15.8% above average, 26.3% average, and 26.3% not assessed. A total of 73.4% of the field instructors responded 3.0 or higher. The aggregate mean is 3.00 which is under the program's benchmark. (5.2) Assess how social welfare and economic policies impacts well-being, service delivery, and access to social services: 36.8% of field instructor's responded excellent, 21.1% above average, 36.8% average, and 5.3% deficient. A total of 94.7% of the field instructors responded 3.0 or higher. The aggregate mean is 3.89 which is slightly under the program's benchmark. (5.3) Apply critical thinking to analyze, formulate, and advocate for policies that advance human rights and social, economic, and environmental justice: 26.3% field instructors responded excellent, 26.3% above average, 42.1% average, and 5.3% deficient. A total 94.7% of the field instructors responded 3.0 or higher. The aggregate mean is 3.63 which is under the program's benchmark.

Field Instructors' Assessment of Student's Achievement of Practice Behaviors n=20

Sixteen field instructors' rated twenty students' achievement of practice behaviors on a scale of 1 to 5 for final semester spring 2016, with five being the highest rating. A mean score of 4.00 is the program's benchmark for achievement of the practice behaviors. There should be twenty-one students, but one student withdrew from the first course in the fall, so was unable to begin the second course in the spring. Then out of the twenty students, one student passed the first course in fall, but had to complete the second course in the spring. Out of the twenty students, nineteen graduated, due to one student completing his field, but not completing and failing the course.

A total of 85% of the field instructors responded 3.0 or higher. The aggregate mean is 3.90 which is slightly under the program's benchmark. (1.3) Demonstrate professional demeanor behavior; appearance; and oral, written, and electronic communication: 55% of field instructors responded excellent, 10% above average, 15% average, and 20% deficient. A total of 90% of the field instructors responded 3.0 or higher. The aggregate mean is 3.85which is slightly below the program's benchmark. (8.2) Apply knowledge of human behavior and the social environment, person-in-environment and other multidisciplinary theoretical frameworks in interventions with clients and constituencies: 55% of field instructors responded excellent, 0% above average, and 45% average. A total of 100% of the field instructors responded 3.0 or higher. The aggregate mean is 4.10 which is above the program's benchmark. (8.3) Use inter-professional collaboration as appropriate to achieve beneficial practice outcomes: 55% of field instructors responded excellent, 5% above average, 30% average, and 10% not assessed. A total of 90% of the field instructors responded 3.0 or higher. The aggregate mean is 3.85 which is slightly below the program's benchmark. (8.4) Negotiate, mediate, and advocate with an on behalf of diverse clients and constituencies: 55% of field instructors responded excellent, 5% above average, 30% average, and 10% not assessed. A total of 905 of field instructors responded 3.0 or higher. The aggregate mean is 3.65 which is below the program's benchmark. (8.5) Facilitate effective transitions and endings that advance mutually agreed-on goals. 55% of field instructors responded excellent, 30% above average, and 15% average. A total of 100% of field instructors responded 3.0 and higher.

Competency 9: Evaluate practice with individuals, families, groups, organizations, and communities: (9.1) Select and use appropriate methods for evaluation of outcomes: 50% of field instructors responded excellent, 15% above average, 25% average, and 10% not assessed. A total

of 90% of the field instructors responded 3.0 or higher. The aggregate mean 3.85 which is slightly below the program's benchmark. (9.2) Apply knowledge of human behavior and social environment, person-in-environment, and other multidisciplinary theoretical frameworks in the evaluation of outcomes: 55% of field instructors responded excellent and 45% average. A total of 100% of the field instructors responded 3.0 or higher. The aggregate mean is 4.10 which exceeds the program's benchmark. (9.3) Critically analyze, monitor, and evaluate intervention and program process and outcomes: 55% of field instructors responded excellent, 5% above average, 35% average, and 10% not assessed. A total of 90% field instructors responded 3.0 or higher. The aggregate mean is 3.85 which is slightly below the program's benchmark. (9.4) Apply evaluation findings to improve practice effectiveness at the micro, mezzo, and macro levels: 50% of field instructors responded excellent, 5% above average, 35% average, and 10% not assessed. A total of 90% of field instructors responded 3.0 or higher. The aggregate mean is 3.75 which is slightly below the program's benchmark.
